It is the goal of San Luis Coastal Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

**Pesticide Use [E.C. 17612, 48980.3; AR 3514.2]**

The district is proactive in the reduction and management of pesticide use at school sites. The goal is to use the least toxic methods and only as needed. The insecticides used are less toxic than most national brand products on the shelf at the local store. The State of California has mandated that all school districts annually notify parents of the pesticides intended for use on school grounds within the coming school year, and the active ingredients of these products.
